## RECLAIMING OUR WHITE CULTURE

In particular, we must not allow the Jew destroyers to sever us from the great culture of our ancestors as it is their drive to do. ### **PM Hale Applies for Law License in Montana**

On Saturday September 23, PM Hale mailed to the State Bar of Montana his completed application to the Bar of that state. This begins what will quite possibly be another huge struggle to obtain a law license that should so obviously be his--a struggle that will quite possibly bring further extensive media publicity to our great Cause.

After mailing the application, PM Hale said the following: "I am calling upon the state of Montana to simply follow the supreme law of the land: the Constitution of the United States. If the officials involved do indeed follow the Constitution, there is no doubt but that I will be admitted to the practice of law in Montana. Montana has the chance to affirm its commitment to the principles upon which our nation was founded rather than do what Illinois has done and eviscerate those principles. The fate of freedom everywhere will in no small part rest upon the choice that Montana makes in this case. My followers and I want to be assured that Constitutional rights do exist for all citizens of the United States regardless of religious belief, and not just for those who subscribe to 'politically correct' religious beliefs...I hope to be admitted and sworn in as a licensed attorney in the state of Montana without fanfare. However, if Montana goes the unconstitutional and immoral route of Illinois, I will of course have no choice but to fight tooth and nail for my license in Montana regardless of the cost. In other words, I will uphold the Constitution even when those in power who have a duty to uphold it are determined to destroy it."

The scene of the town meeting was the nigger 16th Street Baptist church which had been bombed thirty-seven years earlier as part of the resistance of White people in the South to the Communist inspired civil wrongs movement.

The event was broadcast on MSNBC and undoubtedly many Creators and other White Racial Loyalists tuned in to this program. If you did, you know that it was a propoganda exercise aimed at instilling as much guilt in the White population as possible--that it had nothing to do with having a genuine meeting on the subject of Race with all views represented and the beliefs of those represented set forth in a fair manner. Instead, of course, the swine who put the show together went overboard in their effort to smear our Church and yours truly. However, I am happy to say that as usual, their pitiful attempt failed miserably. While I had little actual airtime, I said what needed to be said.

If the show made you mad, this is good. If it made White people around the country mad at the obvious set-up, then this suits our Cause quite well. The enemies of our people were determined to have me outnumbered a thousand to one hoping that this would undermine my message. They undoubtedly also thought that I would waver and compromise since I was in a "church" surrounded by layer upon layer of mud. Their expectations were obviously foiled. ### **What Rights?** by Rev. Kenneth Molyneaux

On a cloudy day in Northern Ohio, Brother Brian Weaver and I decided to spread the great creed of Creativity by spreading fliers out at a local mall. The warm July afternoon was well suited for our crusade. Quickly we went about our business by placing hundreds of fliers on the windshields of the cars in the parking lot.

About a half hour into our distribution, we were harassed by Akron police officers who demanded that we remove the fliers we had just spread. Knowing that our right to spread literature is guaranteed under the Constitution, we declined the officers' request and exercised our right to silence by proclaiming, "I have nothing to say."

The officers trampled our rights and threw handcuffs on us while they escorted us to a detention area. We would not entertain the officers with answers to their questions and kept our cool even when one particularly offensive officer made homosexual comments. The officers even commented that the Church was a gang as we were both wearing Church shirts (by this logic, all police officers should be considered gang members as they wear similar uniforms) and that they hoped we would get a Jewish judge for our trial. The officers contemplated the charges against us and decided not to try for hate crime charges. We were charged with criminal trespassing and littering.

After about an hour wait, we were finally taken down to the jail. Our time in jail was an educational one as we observed the niggers first-hand in their environment. There were Whites present--as police officers, that is. Some of the police officers were aware of the bogus situation and helped us by situating the two of us in a cell away from the growing swarm of filth. After spending most of the day and part of the night in custody of the police, we were finally released.

Several weeks later, on August 22nd, we attended the pretrial with the hope of having the bogus charges dropped. However, this wasn't to be. We were assigned a mud lawyer who knew very little about law and turned out to be an intern. We were offered five days of community service if we plead "no contest" but we knew we hadn't committed any crimes and rejected the offer. We chose a trial by jury that was scheduled for August 30th.

A day before the trial, the lawyers (we had gotten a second lawyer who was Jewish) informed me that they wanted more time to prepare a motion to dismiss the charges as the prosecutor had revised the littering code charge. I had no problem with this, but there was a misunderstanding between the Jewish lawyer and Brother Weaver. The Jew deceived Brother Weaver with the result that Brother Weaver was unable to make the trip from New York to Ohio in order to attend the trial.

The trial didn't take place on August 30th, however, as the continuance was granted and the trial was rescheduled for September 13th. As he hadn't signed a simple piece of paper in the court room, a warrant was issued for Brother Weaver's arrest as he hadn't made the seven hour trip to stay in a court room for several minutes.

On September 13th, the trial finally took place as I had mud all around me. I had a mud lawyer, a Jewish lawyer, and there was a Jewish judge. In addition to this, vital evidence was denied by the judge. The many Supreme Court cases supporting the right to distribute literature was not allowed to be presented to the jury. Also, evidence showing that no one had ever been convicted of violating the flier ordinance I was charged with was likewise ruled inadmissible. Despite this, I was confident of victory as the prosecution had not proved that I had committed any crimes. In order to be found guilty of littering, one must be shown to have done so recklessly and this was never even mentioned in any testimonies. The trespassing charge was similar as no one had ever asked us to leave and anyone is allowed at a public place like a mall.

I hadn't seen any point in taking the stand myself so I refrained from doing so and let the prosecution try and prove me guilty. The jury itself consisted of seven Whites and one nigger. They took approximately thirty minutes to deliberate my fate.

I was asked to rise as the verdict was pronounced and did so. With my head held high, I received the absurd ruling of guilty on both charges. Sentencing commenced shortly thereafter and I was handed the maximum penalty possible: ninety days in jail with a \$750 fine. Two days of the jail time were suspended as I had spent a day in jail when I was arrested and since there were two charges, it came to two days. With court costs, the fine came to \$1157.

While I am not surprised by the ruling, I was disappointed as I had hoped that at least one decent person would have sat on the jury. I am, of course, appealing the decision and hope to get it overturned. If this isn't possible, I hope to learn from the whole experience and hope that the trial's outcome has opened people's eyes to the decaying system around us.

Come what may, the mighty juggernaut that is Creativity will continue on its unstoppable path. Our White Racial Comrades will continue to make this a Whiter and Brighter world no matter what obstacles stand in our way. I deeply thank all those who have expressed their sympathies concerning this miscarriage of justice. Any further assistance would be greatly appreciated. RAHOWA!

**The Test of Life**

"For it matters not how small the beginning may seem to be: what is once well done is done forever."--Henry David Thoreau

You are an animal. Never mind all the trappings of civilization and "superiority" complexes. You must eat and drink. You must survive long enough to reproduce and raise healthy, strong, and intelligent children if you want your kind to continue. You must strive to be healthy, strong, and intelligent yourself in order to live long enough to reproduce and raise children in that mold. Every animal's purpose in life, including yours, is the survival, perpetuation, and growth of its own kind.

Everything that exists in the cosmos is "born" according to the Laws of Nature. Everything lives and dies according to the Laws of, and within the realm of, Nature. Nature (though we sometimes capitalize it) is not a being or god, but a system of rules within which everything operates. For example, an overabundance of pollution over a city decreases the amount of sunlight available to plant life which produce oxygen as a result. This in turn increases the amount of toxins ingested by people thereby causing respiratory illnesses among people. This valid, though simplistic, example, shows the odds of "beating the system" of Nature. Only by understanding and operating within this system can illness, and in the end, extinction, be avoided. Believing you, or people in general, can conquer or control Nature is ignorant and arrogant nonsense.

Every animal is endowed with certain instincts and capabilities when they are born. In order to comply with Rule No. 1--the perpetuation of their own Kind, they utilize these endowments to the fullest extent they are able. Rabbits raid gardens, hop and hide from predators, and reproduce early and often. Wolves establish territory, marry, and raise well their few healthy pups. While each individual rabbit or wolf family works extremely hard to ensure the survival of their offspring, in the long run, it is the survival of their Kind as a whole that matters most. Many rabbits die, but their quantity ensures some will survive. Wolves, on the other hand, rely on quality, so the parents spend a lot of time and energy teaching the pups how to make it.

Unfortunately, due not only to the propaganda of our enemies, but also to our status as the top dog of Nature for so long, our people have forgotten that it takes hard work to attain or maintain good life. For years, we have rested on our laurels, mistakenly assuming the values and abilities which made us Nature's Finest were no longer needed and that the battle was won. However, the Laws of Nature show incontrovertibly that the struggles of life, and for life, never end. Any animal that ceases to work for life earns death. Any species or subspecies unable or unwilling to compete becomes extinct. If you and yours do not strive, you die. No ifs, ands, or buts about it. I received mail from a number of people at that time telling me that it would be impossible to ever compete with the stranglehold the Jews have on the movie industry, that films depicting pro-White themes would never see the light of day, they could never be shown anywhere, and that there would be no audience for them even if we could make them, and besides, I was told, no one in the White Cause has the money to make even a "low budget" film. The naysayers were more in abundance than those who were optimistic.

However, all were in agreement that it would be fantastic if such films could be produced. Needless to say, I had to admit that it didn't seem realistic to envision a day when we could create a separate, pro-White film industry on a par with "Hollyweird". Yet, I continued to dream of a beautiful new future when White films and filmmakers would flourish and draw an enthusiastic audience, bonded in solidarity.

I instinctively felt the Internet held the key to this film revolution, although I knew nothing about the technology involved. The good news is that this technology is now here, ready and waiting for us to utilize to the fullest extent. In the August 25 issue of the Sacramento Bee, there was an article entitled, "New Technology Makes Filmmaking Possible For Everyman." The article describes digital technology, in which films are done on digital tape, transferred to a computer, and edited digitally with widely available software. The article describes two brothers who have made a film for less than \$500. They advertise their film on their website and distribute it free to anyone who sends in a videotape or CD. It is estimated that you can get into the DVD filmmaking business with a minimal investment of \$1,000 to \$4,000 for a camera, \$1600 for the computer software, and \$1,000 for the software. It's almost the equivalent of having your own movie studio. Digital filmmaking is the wave of the future for White racialists. For around \$5,000, it is thrilling to think that it's now possible for racialists to send our message out to a world hungry for salvation. We Creators are already utilizing the audio capabilities of the Net to reach the masses of our People, but we haven't made full use of the video capabilities. Yet, it is there waiting for us. Never again can we allow excuses of "it won't work" or "the Jews won't let us" hold us back in the area of filmmaking.

I personally taught myself how to make audio presentations for the Internet. It wasn't easy, and I'm still learning, but it was exhilarating to go into Radio Shack and buy a headset and microphone. For the grand total of \$6 and some free software that I downloaded from the Internet, I was able to put my voice on the Net as well as record our other Church shows and speeches so that the powerful motivation of a live voice would be available to our Brothers and Sisters visiting our websites.

Today, the Net is the only viable avenue we have to create our own media. The Jews no longer have a "lock" on all media, whether in the form of publishing, music, audio, or film. The Internet has leveled the playing field in astounding ways. I'm positive that we will soon see digital films produced by our best and brightest. Indeed, there may already be such films in production. If you are a filmmaker and are using digital equipment, we'd love to hear from you and share ideas on how we might go about producing a film depicting Creativity in all its glory. Apart from the technical advances, of course, there is still the need for writers, actors, set designers and the many talented individuals who are part of the filmmaking process. We encourage anyone who might be interested in exploring these ideas to get in touch with us, and let's see what the possibilities are. The WCOTC is leading the way in a variety of areas, from our women's activism to our websites to audio and video. We will continue to lead, and be the most progressive and dynamic pro-White organization in the world today.

If you'd like to find out more about digital filmmaking, there are a number of areas on the Internet which discuss the technical aspects, as well as books and other reference materials. Yes, money is necessary, but it's no longer a question of needing millions to make a movie. Distribution can be done over the Net through a website. We don't need a fortune to insure that our Creed is memorialized forever on film. While our Pontifex has certainly appeared countless times in the Jewsmidia, it would be wonderful to showcase him in a film of our own, written and produced by Creators, unedited and uncensored, for the pure consumption and enlightenment of our People. Such a day, Brothers and Sisters, is within our grasp! What better way indeed to win the propaganda war than with Lights, Camera and above all.....ACTION! RAHOWA!

Anti-discrimination groups disturbed by racist cable show

The self-proclaimed "fastest growing racist and anti-Semitic organization in America" will begin airing its message on Valley public access television this week.

The first episode of "White Revolution," an ongoing series produced by the World Church of the Creator, is called "The Truth About Ben Smith" and airs Friday at 6 p.m. on channel 10A.

Associated with the organization, Smith killed two people and wounded nine in a July 1989 shooting rampage in Indiana and Illinois. All Smith's victims were black Jewish or Asian-American.

The Rev. Matt Hale, who heads the white supremacist group, said by telephone Tuesday he thinks Connecticut's lean toward liberalism makes it ripe for the show's message. Some people aren't

going to agree with the liberal majority and may be receptive to the church's message, he said.

"We want to have a show that basically represents the white racial loyalists. If you're white, you should be loyal to the interests of white people," Hale, 29, said from the church's headquarters in East Peoria, Ill.

In a press release dated Monday, Hale in particular hoped many white children watched the show "so that they can learn and accept the Truth before having their minds polluted with anti-white concepts. In other words, we intend to teach white youth through this program to be as racist as possible."

The show's intent sparked concern among leaders of area civil rights groups Tuesday.

"Citizens should do themselves and their families a service and ignore this," Steven Sheinberg, associate regional director of the Anti-Defamation League Connecticut office.

Sheinberg, who worried that the group might garner free publicity, said an article about the show was just another outlet for the church's message.

"This is a fast-growing hate group that has been thriving on the publicity given to it," Sheinberg said.

The show debuted in Connecticut earlier this year on a cable system that serves the greater New Haven area. Tele-Media, the latest cable system to receive "White Revolution," broadcasts to about 90,000 homes in Naugatuck, Beacon Falls, Shelton, Ansonia, Derby, Seymour, Oxford and Bethany.

Hale, who calls himself a racist, isn't content with the show airing in southern Connecticut, predicting a time when every public access station in Connecticut carries "this radical racist program."

Connecticut is the fourth state -- the first three were Illinois, Washington and Indiana -- to air "White Revolution." Since its March 1 inception there have been 26 half-hour episodes.

Sheinberg, of the Anti-Defamation League, encouraged Tele-Media to "send a clear message" they don't support the church's views by running a disclaimer or counter-programming, which he said the ADL would be happy to provide.

Although Sheinberg conceded the program itself is not a threat, "it represents and stands for dangerous ideas."

"This is a group that has been associated with dangerous activity in the past."

Vince Caramanella, general manager of Tele-Media, said Monday he was not aware of "White Revolution's" origin or background.

When told of the show's producer and content, Caramanella said: "Our obligation is to run public access television on a non-discriminatory basis. We're required to do so and we do so."

Under the First Amendment, which protects free speech, the show has a right to air on public access television.

Jimmy Griffin, president of the Waterbury chapter of the National Association for the Advancement of Colored People, respects the church's right to free speech, he said, but disapproves of its message.

"I think anything that shows any type of racial overture is disturbing," he said. "We need to be looking at more unity and diversity."

Griffin characterized as "unhealthy" any negative message that adds to the region's racial problems, citing a greater Waterbury cable access show hosted by blacks as another example of something he thinks crosses the line.

"It's almost the flip side of it," Griffin said, adding "But we still disagree with that (message)."

According to Anti-Defamation League literature, church members have been linked to violent acts against minorities.

But Hale said his group disavows violence and chooses rather "to fight within the system to change the system." Shows like "White Revolution" help deter violence by letting people speak out instead of act out, he said.

"If they try to muzzle us, that might result in violence. I don't mean that as a threat, but when people don't have the opportunity to share their views," it leads to crime and violence, he said. "I don't want to see that."

Despite Hale's remonstrations, a weekly message at Hale's church in Illinois is laced with racial and religious epithets.

Hale plans visit to Bloomington

Matt Hale, the East Peoria white supremacist who has gained national attention, said he will speak in Bloomington next month to counter the pro-tolerance, pro-integration messages promoted here.

A group advancing racial diversity will hold a potluck and celebrate racial differences nearby.

Hale has reserved the Community Room at the Bloomington Public Library for a 2 p.m. meeting Oct. 28.

Matthew Kubiak, the library's executive director, said he has no legal grounds to keep Hale from the facility.

Hale leads the World Church of the Creator and advocates total geographic segregation of the races. He will direct his message here toward the Nov. 7 elections and encourage people not to vote, because voting is an endorsement of a fraudulent system that does not properly represent white people, Hale said.

The Not In Our Town influence in the Twin Cities also needs to be countered, he said.

"I consider Bloomington-Normal a good place for us, especially with all this minority pushing," Hale said during a telephone interview. "You can't have diversity without white people getting the shaft."

The Coalition for Diversity and Reconciliation, meeting at Moses Montefiore Temple for its monthly gathering Wednesday, decided to mark Hale's visit by holding its annual fall potluck the same day at a downtown location.

"It will be an opportunity to celebrate diversity and reaffirm our commitment," group spokeswoman Barbara Adkins said.

She said confronting Hale and his message would be counterproductive to the message of the group.

Hale has appeared in national media and at various forums. His

White supremacist plans Oct. 28 speech

Matt Hale intends to address Not In Our Town movement

BLOOMINGTON — White supremacist Matt Hale said he plans an Oct. 28 appearance in Bloomington-Normal to counter calls for racial tolerance.

Hale, an East Peorian and leader of the Worldwide Church of the Creator, will speak at 2 p.m. at the Bloomington Public Library. He will talk about Not In Our Town anti-racism efforts as well as the upcoming presidential election.

On the same day, the Coalition for Diversity and Reconciliation and their allied organizations will hold their annual potluck, said Bloomington Development Director Barbara Adkins. The dinner will be downtown at a site to be announced.

Adkins said she suggested the groups hold the potluck the same day to provide a counterpoint to Hale's appearance.

"We won't be out there protesting and denouncing Matt Hale publicly, because that's not what we do," Adkins said. "We celebrate our diversity here, and we want to show that him coming here is not going

to deter us."

For his part, Hale said Thursday he does not plan to disrupt the pro-diversity event.

"We're here for white people who want to hear our message," Hale said a member of his church invited him to speak in Bloomington. The member was dismayed the church has not reacted recently to the Not In Our Town movement.

"We always felt Not In Our Town has exaggerated their influence and support in Bloomington," Hale said. "I'll have something to say about the Not In Our Town group and our different view of race relations."

Hale said that in his one-hour talk, he will discuss how his group can recruit more members in the Bloomington area. He also will discuss the presidential race.

None of the candidates stand up for issues important to white people, Hale said.

Republican George W. Bush and Democrat Al Gore are "two sides of a rotten coin, and we'd rather chuck the coin rather than putting it in our pocket," he said.

Hale's last appearance in the area was in October, after a lawsuit he filed to force the Illinois State University Global Review forum to let him speak was dismissed in McLean County Court.

fitness." He appealed to the U.S. Supreme Court, which refused to hear his case earlier this summer, effectively killing any chance Hale had of obtaining a law license in Illinois.

Hale has consistently maintained his denial was a violation of the First Amendment. State Bar officials deny that, saying Hale did not have the moral character to be an attorney in this state.

The World Church holds a convention each year in Montana. A spokesman for a Montana civil rights group said about two dozen people have attended the gatherings. Hale said his group has about two dozen members in the Missouri area, but he declined to give a membership estimate for the state.

movement gained increased attention after a former follower, Benjamin Smith, in August 1999 killed two people and wounded nine in Illinois and Indiana in a racially motivated shooting rampage that ended when he killed himself.

Hale seeks Montana license

EAST PEORIA — Avowed white supremacist Matt Hale has applied for a law license in Montana.

Hale, 29, of East Peoria confirmed he mailed the application to the State Bar of Montana on Saturday. The application means Hale is seriously considering moving his anti-Semitic World Church of the Creator out of central Illinois.

"If they were to accept me tomorrow, I would be there by the weekend," he said Monday night. "But if I do go to Montana, I am not going to forget about here. This is my home. I have family here."

Last year, Hale was denied a law license by an Illinois panel that judges prospective lawyers on their "character and

# Racist literature investigated

White supremacist pamphlets spark police, D.A. inquiry

Croton-on-Hudson police are investigating the distribution of white supremacist literature that has upset some residents in a village neighborhood.

The 32-page pamphlet, called "Facts That the Government and the Media Don't Want You to

know," details the views of the Rev. Matt Hale, the self-proclaimed "pontifex maximus" of the Illinois-based World Church of the Creator.

Hale believes in the supremacy of white people and seeks to deport everyone in the United States who is not of European descent, including all Jews.

"We see our duty to preserve our own kind, to preserve our own race," Hale said in a telephone interview. "That's the law that guides all life on this planet."

Croton police Detective Lt.

Anthony Tramaglini said he was conducting an investigation of the literature in collaboration with the bias crimes unit of Westchester County District Attorney Jeanine Piro.

The police started their inquiry after they were alerted by residents of Penfield Avenue in Croton-on-Hudson, who found the pamphlet at the end of their driveways.

"I read one of the articles, and it was anti-Jewish and anti-black," said Croton resident Michael Spitzer. "It was pretty obnoxious."

At the World Church of the Creator's Web site, Hale urges his followers to distribute the brochure in neighborhoods as a way to spread word about the religion, which was founded in 1973.

Rabbi Helene Ferris of Temple Israel of Northern Westchester said she opposed the views, but she was not too concerned. She said that it was better for the material to be out in the open so people could read it, reject it and work against it. "It exposes the hater," she said. "Some of the things are so out-

rageous. But the crazier they are, the worse it is for them. Once the haters are exposed, you can counterattack."

Tramaglini declined to comment on the investigation. Hale suggested that authorities investigating his literature read the First Amendment to the U.S. Constitution, which he said protects his followers' rights to distribute the pamphlets.

"The police should grab a cup of coffee and a doughnut and just kick back and read it," he said. "If they accept it, fine. If they don't, that's fine too."

# Black, white still color life

Racial perceptions persist, speakers say

More than 1,000 people at Sixteenth Street Baptist Church on Tuesday night watched with millions a wide-ranging televised discussion of American race relations.

The meeting, sponsored jointly by MSNBC and Newsweek magazine featured celebrities, authors, athletes and actors. The

panel cast a swiftly moving light on subjects from racial profiling, to the paucity of minorities in movies and television, to hip-hop music, to affirmative action and education.

Moderator Brian Williams, MSNBC news anchor, said security at the church was tight because some people didn't want the issues aired. All the more reason to talk, he said.

"That's why we are here."

Talk they did.

Panelists included O.J. Simpson defense attorney Johnnie Cochran, the Rev. Al Sharpton, MTV announcer Amanda Lewis, basketball player Kevin Johnson, author Dr-

neah D'Souza and Seattle Times columnist Mark Tabaran.

Sharpton and Cochran said racial profiling of minorities by police is more than just a matter of harboring stereotypes. In some cases, it's a policy, they claimed. "We're still facing laws in this country that institute a racial policy that is unfair," Sharpton said.

Businesswoman Valerie Bradley told the audience she had been harassed for "being white black" when U.S. Customs agents came to search her at the Newark International Airport in 1998. "In another

room, it would have been sexual assault. It would have been criminal. But it happened at the hands of my own government," she said.

The two-hour program included the segregationist views of Matthew Hale, leader of the World Church of the Creator. Hale blamed people such as Williams for fostering attitudes that forced integration against white people's will.

"Millions of white people out there listening agree with what I'm saying. They don't buy this multi-cultural nonsense," Hale said. "They want a white community for themselves, not an integrated cesspool," he said, drawing sibilant hisses and boos.

Hale sat in the church where a bomb planted by segregationists killed four girls on Sept. 15, 1963.

The meeting, part of a two-day summit on race relations called "The New Color Lines," was held to coincide with the anniversary of the bombing.

The event continues today with all-day

discussions at the Alys Stephens Performing Arts Center at the University of Alabama at Birmingham. Luncheon speaker will be the Rev. Jesse Jackson.

Newsweek's Sept. 18 issue features a report on race, including a look at conditions in Birmingham, then and now. It also offers reports on Americans of Asian, Arab and Latin descent.

Several attendees Tuesday night said they enjoyed the discussion, but wondered what positive action would result.

"My question is, 'Now what?'" said Sis Levin of the Highland Park neighborhood, who came to the meeting with her husband, Jerry. "It's very frustrating to do something like this if there's not going to be a real process. Are we going to process this? Are we going to have some planning come out of this. Otherwise it's just another talk-it-over."

Mike Calvert, director of Operation New Birmingham, said he hopes the meeting will spark further discussion and action as Birmingham and the nation wrestle with racism.

The problem isn't just the small minority of conscious racists, he said. "The much bigger problem is people who think of themselves as good people, well-intentioned, but hardly conscious of the damage they do with racial stereotyping and all that," he said.

## Supremacist convicted of littering

Man guilty of trespassing at Chapel Hill Mall and leaving racist fliers on vehicle windshields

The white supremacist looked around the courtroom and saw a lot of color.

Charged with littering and criminal trespassing for distributing racist fliers at Chapel Hill Mall, Kenneth Molyneux found himself represented by two court-appointed lawyers, both of whom are minorities.

His judge - Akron Municipal Court Judge Marvin A. Shapiro - was Jewish. And finally, the only black on the jury was selected as the panel's foreman.

After a one-day trial yesterday - and less than 30 minutes of jury deliberations - Molyneux was convicted on both counts.

Shapiro then sentenced him to the maximum: 90 days in jail and a \$750 fine.

It was the first time anyone in Akron was convicted under the section of the city's littering ordinance that prohibits leaving materials on car windshields.

The jury foreman wanted to make it clear that he voted to convict because of the littering, not because of Molyneux's

message. "Being African-American, I just wanted to separate the law from the materials being passed out," said foreman Reuben Greene of Akron. "He was asked to pick up the fliers and leave. And he didn't."

Greene compared Molyneux's stance to that of the black civil rights sit-ins of the 1960s.

"Maybe he was just trying to draw publicity to his cause," he said.

Molyneux, 22, was arrested with Brian Weaver on July 29 after mall employees spotted the pair placing fliers on car windshields, a violation of mall

Young, who watched the first installment of "The White Revolution" found it "very boring. It was threatening. I thought it was ominous, I was offended by it," Young said, adding she planned future screenings to see if there were any legal challenges her organization might make regarding the show's content.

AT&T, the cable advisory council's Guilford representative, said viewers who filed the show objectionable have a lot of options. "One is turn it off or plug into a different channel; if you really don't like it, make your own tape and take a countering position," he said.

Besides the first two segments, Finley reported an additional two editions of the show will be aired in October and November.

Asked if Molyneux's view also played a part in his sentencing decision, Shapiro said after the trial, "I hope not. As a judge, you just try to do the right thing."

The trial was attended by a representative from the Anti-Defamation League and two representatives from the Jewish Defense League, who said they stalked out Molyneux's Akron home and followed him to court yesterday morning.

The men also said they sent letters to Molyneux's neighbors, about half of whom are minorities, informing them of his racist beliefs.

"We're happy that the city of Akron enforced their statutes and got some hate off the streets," said Bettsyue Feuer of the ADL.

Molyneux did not take the stand during his trial.

Public defenders Joseph S. Kodish, who is Jewish, and Angela R. Walls, who is black, tried to convince jurors that Molyneux was targeted by police because of his unpopular views on race.

The defense team tried to point out that when Molyneux and his friend were confronted in the mall parking lot by Akron Patrolman Rod Criss, they were not told to leave, as required under the city's criminal trespassing statute.
